This letter is to advise you of an outdoor event that the Union Hotel is holding on **Waymouth Street Between Bentham and Young Streets** on **25th April 2019**. This will be a **ANZAC Day Street Party** beginning at **10am** and finishing promptly at **10pm**. Expected attendance at the event is **1100 at any given time**.

The event is a post ANZAC march gathering of current and ex service men and women, their friends, family and the general public. There are live bands, food stalls and bars serving drinks. Free entry.

The event will be appropriately monitored both internally and externally by our security company to ensure minimal disturbance from our patrons.

Road Closure Details

Waymouth Street between **Bentham Street** and **Young Street** will be closed to vehicular traffic on the following date and times:

- **0600 25/04/19 and Midnight 25/04/19**

Temporary Parking Controls: To facilitate the road closure all the on-street parking spaces on **Waymouth Street** will be changed to no stopping. The signs will be installed the day before the event and removed the day after the event.

Pedestrian access will be maintained along Waymouth Street and the event site will not be fenced.

Event Noise

The event will adhere to City of Adelaide (CoA), and Liquor Licencing requirements.

Noise levels will be monitored throughout the event to ensure that we do not exceed the maximum noise levels permitted by the CoA Event Noise Mitigation Standard Operating Procedures.

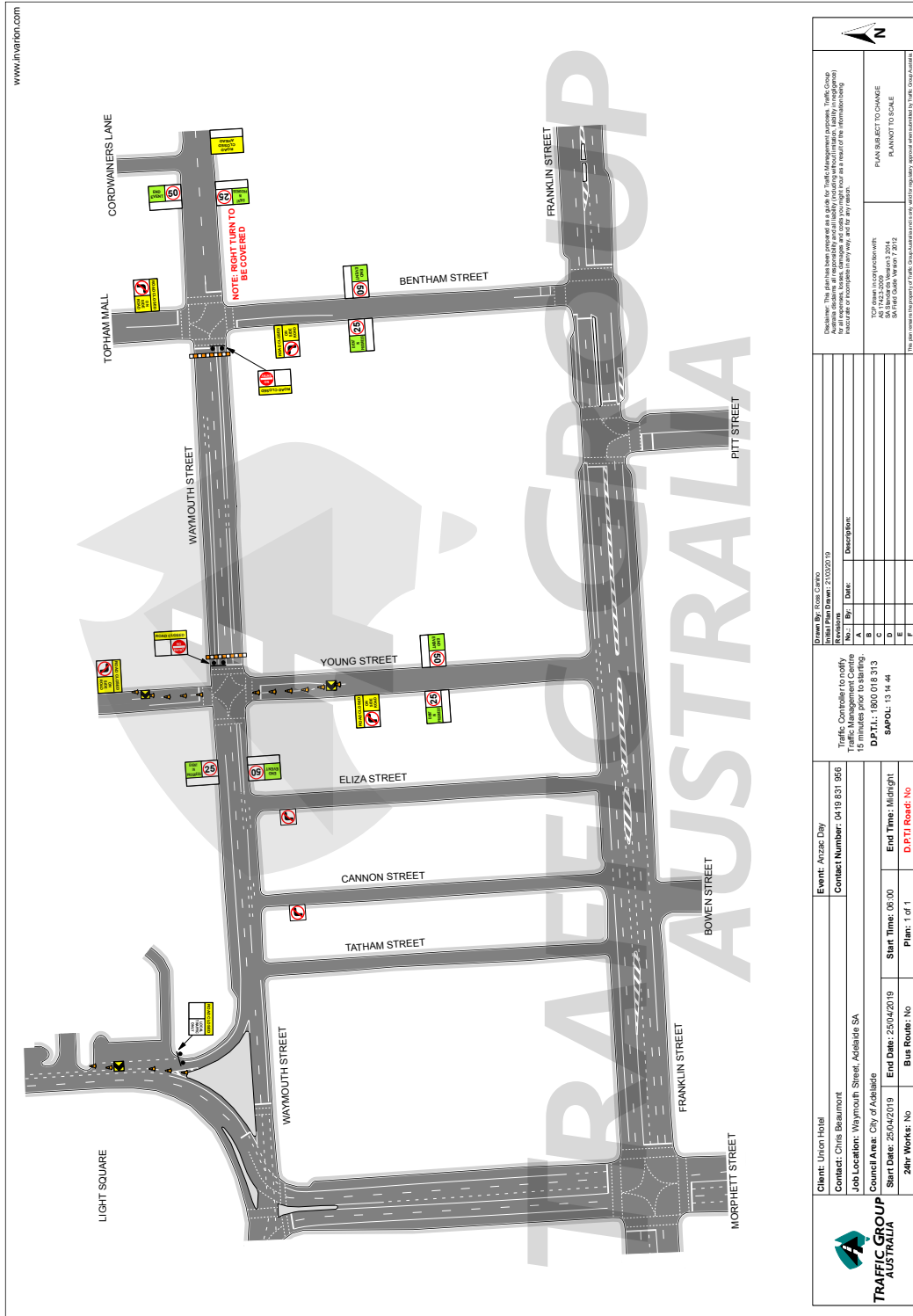
